Terms and Conditions

- 1. Quotes and proposals do not guarantee availability of a tent. Tents are reserved only upon receipt of a signed rental agreement and a 50% security deposit. Full payment is due the day of setup.
- 2. A refundable security deposit of 50% is required to hold equipment for the date of the event. Please send a check and filled out copy of this document to the address listed above. Final payments are due on date of setup. ASMC will accept cash or check made payable to the Aurora Shores Men's Club. A delivery fee of \$25 will be assessed for deliveries outside the village limits of Reminderville. Security deposit will be returned upon final inspection and teardown.
- 3. Installation of a tent must be done correctly for the protection of the users, the tent, and ultimately the success of the event. Therefore, it is the strict policy of the ASMC that all setup and tear downs be performed by ASMC crews. All rentals include equipment, setup, and tear down.
- 4. Rentals are normally setup the day before and taken down the day after the agreement date. In some circumstances Sunday rentals are put up early in the morning on Sunday (7am 9 am) and Saturday rentals are taken down early on Sunday morning (7am 9am). In all cases ASMC will contact you on the Wednesday prior to the date to confirm setup and tear down times. For specific setup / tear down times please call at least 10 days in advance.
- 5. Client understands that tents are temporary structures designed to provide limited protection from weather conditions, primarily sun and rain; however, there may be situations, particularly those involving strong winds and lightning, in which tents will not provide protection and may even be damaged or blown over. Evacuation of tents to avoid possible injury is recommended when severe weather threatens the area where tents are erected. People must leave the tents and not seek shelter in tents during such conditions. it is best to evacuate when in doubt. If anything happens please contact the ASMC and we will care of it. ASMC reserves the right to take a tent down to prevent equipment, persons, and property from any possible harm and damage. We also reserve the right to cancel an order in the event harsh weather doesn't allow for setup or will cause harm to any rented equipment, as well as persons or property. In this rare event, your deposit will be refunded in full.
- 6. The Client is responsible for all equipment from the point of delivery until pick-up. The Client will also take full responsibility and will be held liable for any damages that occur to any / all equipment. Client will be charged for damaged, broken, lost, or stolen equipment at replacement prices.
- 7. ASMC will do its best to protect your property during the delivery, setup, and tear down process. The Client agrees to release ASMC of any liability for any damage to any property due to delivery, setup, and tear down / removal of equipment on your property. This includes, but is not limited to, damages from stakes, poles, and other equipment necessary to keep tent stabilized. The first step ASMC crews perform when installing a tent is to spread it flat on the ground where it is to be set up. Please have this area completely cleared of any obstructions before our arrival at the setup location. In like manner, the tent must be completely empty before ASMC can take it down. To avoid unnecessary damage to your homes underground utilities please have all underground piping (ex: sprinkler system, septic, electrical lines) marked prior to our arrival.
- 8. In consideration of acceptance of this rental agreement, I do hereby, for myself and my heirs, waive and release all rights and claims for any damages which I may have or which may hereafter accrue to me, against the Aurora Shores Men's Club and its members in conjunction with the subject tent rental.
