No fee.</p> <p>Reoccurring ACH – A reoccurring direct debit withdrawal enabling owners to determine the date of the debit, AAB will send the owner a reminder email prior to debit. No fee.</p> <p>Credit Card – All credit cards are accepted. Three percent service fee charged to the homeowner at the time of the transaction.
